### Call to Order:

# **Finance Report:**

Randy Gooch presented the financial reports for KHDA and the KPHA/KHDA Joint Administrative accounts as of January 31, 2020. The Joint Administrative account had total cash assets of \$123,314.24, YTD revenue of \$132,555.35, total expenditures of \$106,979.83, with a net income of \$25,575.52. The KHDA account had total current assets of \$23,291.95, YTD income of \$176,239.97, total expenditures of \$164,119.32, which leaves a net income of \$12,120.65. Shawn Crabtree made the motion to approve the financial reports, seconded by Georgia Heise. The motion carried.

### **New DPH Commissioner:**

# **CDC Update – Doug Thoroughman:**

Doug reported on the Corona Virus. At present, there are 71,000 cases. There are 794 cases outside of China, with a 2.5% death rate. There have been three deaths outside of China. ### **Harm Reduction – Jim House:**

Jim House spoke about the harm reduction strategy for 2020 and talked about their mobile harm reduction team and their unit.

### **KIRP – Dr. Artis Hoven:**

KIRP stands for Kentucky Income Reduction Program. There is also, KDAP which is Kentucky Department AIDS Program which is housed at University of Kentucky. Their mission is to eliminate HIV, HEPC, and AIDS.

HB129 (PHPT bill) and HB171 (Level dollar funding bill) both have passed the House. SB5 is the bill that gives the Fiscal Court the ability to set tax rates.
